Here are the current contracts for waste hauling which Aspen currently has all 3 – north region, south region and downtown.

The totally receipts from solid waste fees from non-residential accounts in 2013 was \$6,043,676. Non-residential means everything that is not residential so multi-family would not be included in this. If I'm doing my math correctly considering the commercial solid waste fee is 14.5% of billing, that means total commercial (non-residential) waste collection billings in Hennepin County was \$41,01,346 in 2013. By contrast, residential billings which would include multi-family was \$7,550,767.
