Short description of item:

Approve Foth LLC Contract for Solid Waste Organized Collection Work

Council item verbiage:

At the July 28, 2014 City Council Study Session-on, the City Council directed staff to pursue with the implementation of organized collection of trash, recyclables, yard waste and organics.

Staff would like to continue to work with Foth LLC, and their expertise as Bloomington proceeds to implement organized collection by January 1, 2016, or earlier if possible. The City Council is requested to approve the contract with Foth LLC in the amount of \$xxx,xxx, with the funding coming from the reserve fund of the Solid Waste Utility (Fund 535). This cost includes a 10% reserve for the work.

This part below confuses me (mainly the "Foth described" parts of both bullets and the second bullet bolded portion): This funding includes the following work:

- Foth described <u>Phase</u> 3 from September 9th to December 31, 2014, includes the required 60-day negotiation period and meetings with the Bloomington licensed haulers, and the review of the haulers proposal at the end of the 60-day negotiation period. Staff will request the 60-day negotiation period begin on October 6, 2014, after many of the guidance parameters have been approved by the Council for the haulers to incorporate into their proposal submittal. If the Hhauler proposal is acceptable, the Foth work is anticipated to end; if the hauler proposal is not acceptable, staff recommends going to the next phase described below.
- Foth described <u>Phase 4</u> from January 1, 2015 to June 31, 2015 (time is estimated) is to include the next stage of organized collection described in State Statute 115A.94 for the Organized Collection Options Committee(OCOC) to begin, **if the hauler submittal is not acceptable to Bloomington and thus is rejected**. The OCOC is to put together the needs and desires the residents of Bloomington want included in a Request for Proposals that will be sent out to interested haulers for organized collection in the City. If that fails, or is rejected again, the present open collection system would remain-remains in operation.
