INTRODUCTION

The Environmental Quality Committee (EQC) develops a new work plan and committee report every two years. The last session went from 2021-2022 and the current session is 2023-2024. At the beginning of a new work plan, the committee reviews the past session, develops new goals, and presents their report to the City Council at a workshop.

DISCUSSION

In Fall 2022, the EQC members brainstormed ideas for new goals, ranked priorities, and grouped similar categories. The top three categories serve as the group's main goals for the next two years and establish the subcommittees that members join. The following goals and subcommittees were set for 2023-2024:

- Energy and sustainability
- Waste: Trash and organics
- Water

PROBLEM STATEMENT

Shoreview residents are paying too much for an inefficient garbage collection system. Reconfiguring the system can save residents money and help us meet needs identified in the citizen survey to protect our environment and to address climate change.



OTHER POTENTIAL BENEFITS

- Reduce truck traffic
 - Less emissions
 - Less noise
 - Less street wear
 - Increase traffic and pedestrian safety
 - Added services (e.g., bulky item collection, low-volume rates)

WHAT'S NEXT

- City Council provides notice of its intent to consider organized collection
- City exclusively negotiates with its licensed collectors
- Three scenario options:
 - i. City and Collectors reach an agreement
 - ii. City and Collectors do not reach an agreement (can proceed to RFP)
 - iii. City Council decides not to implement organized collection
